

Novated Lease

Novated leasing (also known as salary sacrificing) is a way for you to finance your vehicle making payments directly from your regular pay through your employer. StreetFleet arranges vehicle finance with the appropriate financial provider. Lease repayments and vehicle running costs are invoiced to your employer. Employer deducts those costs from your pre-tax salary.
